The concept of Gender began to be used as a term after his report by the American psychiatrist, psychoanalyst, sociologist Robert Stoller (Robert Stoller) on the study of problems such as personality socialization, social gender, gender self-awareness, gender identity, at the Congress of psychoanalysts in Stockholm. Robert Stoller was the first to distinguish between the concepts of biological sex and sociocultural gender. The development trend, scientific-cognitive, socio-philosophical thinking of Western and Eastern civilization reflected the problems of gender equality for men and women who have undergone a long historical transformation.

The ancient Greek philosopher, whose gender problematics caused heated debate from the earliest times, went through the following historical evolutions, from the ideas that nature, outlined in the works of Antifont, created everyone equally:

- emergence of equality theories;
- suffrage;
- The struggle for the equality of citizens during the French Revolution;
- modern development of the theory of equality of possibilities;
- feminism, Liberal, radical feminism;
- theory of social socialization;
- the problem of differences between men and women;
- Robert Connell's theory of male superiority;
- gender psychology, jurisprudence, gender problem in medicine;
- fight for women's rights, etc.

The Greek philosopher, mathematician Pythagoras argues in his scientific views that a woman and a man were created equal. Such ideas are also found in the teachings of Socrates. Socrates was sentenced to death on charges of poisoning the minds of young people with his ideas about freedom and freedom of the individual, the right of Man and citizens. Plato, the father of philosophy, also advocated these views in the work "the ideal state", demonstrating his loyalty to the ideas of his great comrades. Platon concludes that the difference between male and female nature is relative and applies only to the reproductive sphere. A woman can choose professions at her discretion: music, philosophy or other professions, including military ones. In Platon's work, "can a woman be considered capable of performing this difficult and responsible task? Can the female part of humanity participate in all matters along with men?" he throws the questions to the middle. Platon reveals the social roots of the problem by describing this fact regarding the place of women in society, doomed to "cook soup" and "do nannies" as a result of the strong and long-term influence of tradition, traditions in his time. The great philosopher emphasizes the need to change the approach to the upbringing and education of women, so that artificially formed asymmetry opens the way for the full development of not only men, but all members of society.

A major representative of the Christian doctrine, Foma Aquinas, believed that the main reason for the creation of a woman by God is that she should help men, and this help is expressed in bringing offspring into the world and in household affairs . German psychologist, sociologist, co-founder of neofreydism, representative of humanistic psychoanalysis Erich Zeligmann Fromm in his work "man and woman" two genders

in the analysis of the nature and characteristics of its representatives, the problem of gender equality comes to the following conclusions: "equality means identity. The requirement of equality is polar in nature: despite all the differences, no one should use each other as a means to achieve their goal, since each person is a goal for himself.

The first life experience of each person is communication with his mother. Renowned psychologist, sociologist Carl Jung wrote: "the mother's archetype is the most holistic for the child. This archetype unconsciously retains its strength, unity throughout life. Not every culture shows gender neutrality. The concept of Gender is embedded in culture, in other words, culture is a set of values and norms, attitudes and stereotypes, a system of behavior and social interactions included in social composition, determined by gender. Historically, manifestations of oppression of women were at different times. The Arabian Peninsula was dominated by such cruel habits of the era of ignorance as burying girls alive. In India, there was also, a woman deprived of her husband, who was doomed to burn in alive. In ancient China, the birth of a girl was considered a disaster. The Roman lawyer Papian wrote about the position of women in society as follows: "according to the general rules of our legislation, the position of women is worse than that of men" (Digests). Although free, the woman still did not have civil "freedoms". For example, he cannot serve in the Army, vote at meetings, be elected to public office, be a judge or prosecutor, have no right to conduct a trial as a lawyer of any third party.

"The author of the work" democracy in America", the French humanist and philosopher of the 19th century Alexis de Tocqueville, thinks about this issue: "some argue that a man and a woman are not only equal, but holistic. They not only give a man and a woman equal rights, but also impose homogeneous obligations on them. They want a man and a woman to think uniformly, to work. It does not lead to good, it causes the crisis of Man and woman as gender, it makes weak men and strong women appear".

The great German poet Johann Goethe writes in his famous "This Is The Office of the East" about showing mercy to women: do not oppress women, do not be stony, they were wounded by Crooked ribs after all. Allah has created them so that you may try to correct them. If you put it in your own way it will be worse, son of man, think of yourself which one is better? Have mercy, fight against you. Not good if it breaks one rib. . German thinker Wilhelm von Humboldt has a valuable opinion that "the spiritual progress of every nation is determined by its attitude towards a woman . In Oriental values, a woman has always been glorified as a friend to a man, a guide, a wise, kind, a guide to family peace. In Oriental thought, the position of women in society in the Turkic peoples was very high. Arab historian ibn Battuta gives: "Turkish khakans write" at the behest of the Sultan and his wife"when signing." From the ancient visions of the Turks, such phrases as Eve, Eve, Eve, often testify in our history to the divine

Let your husband hear from you only gentle and sweet words, do not sit in front of him in a naughty or old dress or with no strings attached to your faces, and your hair is not regulated." Abu Ali ibn Sina's views on issues of family relations are also noteworthy. In her work" the event "it is emphasized that women should have the following characteristics: - let them be educated; - let them be faithful; - let them be shy, shame-fantasy; - Let Them Be Brave by nature; - let them love their husband hard; - let them think about childbirth and raising children; - let them not be talkative; - let them obey their husband; - be true, humble and intelligent; - never stutter on his own reputation; - be careful with her husband, putting his respect in place, is obliged to be polite; - know his duty and duty well; - let the wife know how to use things in the family economy correctly, with savings; - let her lose flaws in her husband by her nature and good sides. Islamic teachings glorify female honor.

In the Quran there is a separate Surah "Niso" (women) about women. The wealth of the universe Muhammad (s.a.v. "Paradise is under the feet of mothers." In Islamic law, the requirement of knowledge in the word of Allah Ta'ala belongs to the male and female Muslims. "The demand for knowledge is obligatory for every Muslim." Women are revered in Islam. Alloma Muhammad Ghazali emphasizes that" in the century of bliss, Sahabia women would ride camels (now cars), participate in the ghazals, call the Messenger to the guest, he would serve the breed." Islam showed attention and care to a woman, increased her social level, confirmed that the creation of a woman and a man is the same, and therefore men and women are equal before God. Islam raised the woman to a level that was not raised in any culture. He forbade such a cruel habit of the period of ignorance as burying girls alive, protecting a woman's right to life and treating her well
